This is to inform you that following words have been deleted in our Client Registration form (KYC Form) due to Contravening Clauses in page no. 14, 16 & 17.

1. In page no.14 (Letter of Authorization For Electronic Contact Notes)-word deleted

- (a) "I/We agree not to hold you responsible for late/nonreceipt of contract notes sent in electronic form Authorization to trade and any other communication for any reason including but not limited to failure of email services, loss of connectivity, email in transit, etc".
- (b) "I/We agree that the log reports of your dispatching software shall be a conclusive proof of dispatch of contract notes to me/us and such dispatch shall be deemed to mean receipt by me/us and shall not be disputed by me/us on account of any non-receipt/ delayed receipt for any reason whatsoever".

2. In page no. 16 (Running Account Authorization)

- (a) The word 5 working days is changed from 5 to 2 trading days – in point no. 4.

3. In page no.17 (Lien & Set-Off)- word deleted in point no. 4 & in last paragraph

- (a) "The right of set-off as aforesaid shall extend to my/our trading accounts with respect to all broking transactions with associated concerns, affiliated or sister concern of PRLSS as though such accounts are maintained with PRLSS" – in point no.4.
- (b) "Furthermore the aforesaid lien/set-off conferred on PRLSS shall subsist even after the termination of the aforesaid Member – Client agreements with PRLSS until all obligations under the said agreements are satisfied fully by me/us. The said right of lien/setoff shall be exercised by PRLSS jointly and/or severally by each of aforesaid companies – in last paragraph.
